

## **CSIA Atlantic Region Hall of Fame**

The CSIA Atlantic Region Hall of Fame is dedicated to preserving the history of our Region, inspiring and encouraging the development of young Instructors, and recognizing Members who have made a significant contribution to the growth and well-being of the Region and to the sport of skiing and ski teaching.

The CSIA Atlantic Region Hall of Fame has three categories where inductees can be awarded:

### *Builders*

This category recognizes those who have made a positive contribution to the development of the organization from a regional or national perspective. Builders are defined as individuals who have made a significant contribution to the development and advancement of the CSIA Atlantic Region. Builders may be active or retired at the time of nomination.

### *Contributors*

This category is reserved to honor individuals who have made an impact on the ski industry through their dedication to the sport. These honorees may or may not be Members of the CSIA. This means for the CSIA Atlantic Region to acknowledge and recognize a partner in the industry in our Region.

### *Inspirational Leader*

This category honors and awards individuals that have demonstrated remarkable leadership. They are also perceived as role models are motivational, and they are truly inspirational mentors to other Members and peers throughout their CSIA career.

The induction ceremony for the selected nominees is to be held annually in the fall and usually in conjunction with the regional Members' Convention.

## **Nominations**

To nominate an individual, it is important to state to which of the above-mentioned categories you are nominating that person. Nomination forms can be found herein. This form is designed to help you outline that person's accomplishments and explain the reasons for the nominations. Nominations should be free from conflict of interest or perceived conflict of interest situations. ## **Nominee Eligibility**

Nominees must have been current Members of the CSIA Atlantic, unless otherwise indicated in the category, and must have resided in the Atlantic Region during the period of note. A Nominee may be considered in any of the three categories, however, may not be considered in multiple categories concurrently. The Atlantic Hall of Fame/Awards Committee will screen all nominations as to the legitimacy of the nomination. Their decision should be based on eligibility criteria and whether the achievements or contributions meet the generally accepted standards required for induction. Nominations must be for individuals and not companies or organizations. An individual representing a company or organization is acceptable. Nominees may be living or

deceased at the time of nomination. Individuals may only be inducted once into the Hall of Fame, regardless of the category applied.

**Nomination deadline:** All 2023 nominations must reach the committee by November 17<sup>th</sup>, 2023.

The CSIA Atlantic Region Hall of Fame Committee will consider the nominations and determine who the successful candidates will be. Please note that all nominations remain active for a period of three years, which means that in a case whereby a nomination was not selected for this year, it will be eligible for another two years.

With your help, deserving individuals will receive the recognition they have earned through their perseverance, character, and dedication.
