TRAINER DEVELOPMENT PROGRAM

A. INTRODUCTION

The Trainer Development Course is a two-day program that helps 'experienced' ski instructors explore and enhance their skills as Course Conductors and or Trainers responsible for training, inspiring and influencing new ski instructors. It is a first step in CSIA pedagogical teaching. This is a prerequisite for becoming a Course Conductor (CC) as well as for those applying for the Level 4 Academy, the prerequisite for attending the Trainer Development Course is CSIA Level 3 Certification.

Further training includes but is not limited to:

- L1 CC Training
- Pro Day Trainer etc.

The Trainer Exam can be done before or after the 'further training' that's available.

Modelling and Labelling of processes, decisions and observations that the trainer is making is a primary tool in evolving great teachers into great trainers. A solid understanding of the CSIA teaching and technical concepts is key to delivering a clear and concise message in a simple and digestible manner. The "Model" is what the Trainer provides by working through the teaching process to be emulated. "Labels" provide highlights and create focus on the most important learning moments as you go.

This document is designed to provide a brief outline of the program and includes hyperlinks throughout to provide additional information.

TRAINER EXAM

A. INTRODUCTION

- After completing the Trainer Development Course, participants can attend a scheduled 1 Day Exam with no time limitation. It is required for those wishing to be active Course Conductors and required for the Level 4 Certification.
- The Exam is a “peer teaching” situation, with participants teaching 3-4 other participants. Sessions are 45-55 minutes in duration, including chairlift time. The choice of terrain is at the discretion of the participants. However, if time or terrain availability is a problem, the Course Conductor may help direct terrain choice
- Session context will be chosen by the candidate with no two being exactly the same. The range of "end user" scenarios can be from beginners who are already straight gliding in a wedge, up to Intermediate skiers learning to link parallel turns on blue runs.

Technical information should come out based on assessments and developments done and related to the end user. Note: The candidate should build their session around the context of lesson takers in a performance range between straight gliding in a wedge and linking parallel on green runs. The session should model and label practical teaching approaches for the chosen level of skier that newer instructors can use in their lessons.
